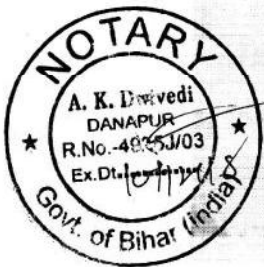
Front view of the Building





Rear view of the building

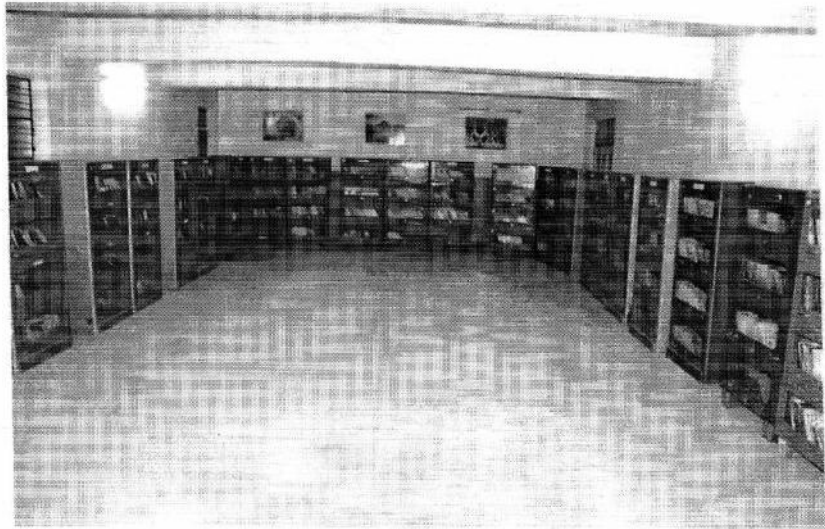
